## **2202/05 To receive Delegate Reports**

Chairman on activities undertaken on behalf of the PC

Cllr Heath has liaised with Wildscapes regarding Howsham pond and reports:

Restoration of ponds is more difficult than creating new ponds. Wildscapes have undertaken one site inspection, but plan to return to undertake another next month. The pond is within the target area. They will need to submit a bid for funding to National England. The next round of funding is available in March and if successful work would be undertaken winter 2022. The programme includes 25-year management of the pond and an annual survey. There is a risk that the work undertaken would not improve the pond. They would need access from the Farmers field behind and would cut down some of the trees that surround the pond. If the pond is found not to be suitable following the second site inspection, then Wildscapes will advise the council on other options.
