Environmental health are doing regular checks on Brigg lane trying to pursue deeper investigation. Doing regular sweeps to gain evidence and prosecuting where they can.

Cllr Waltham has discussed the issues at Candey Bridge with Safer Neighbourhoods who suggest cameras would not be effective as there is no connectivity in the area for data retrieval. He has perused Anglian Water and has an update coming especially as they have an interest in the security of Cadney Bridge and they do have a lot connective in the area. Along with much more signage to come.

There have been some challenges in Bin Collection which has been down to illness

The council has been ordering new vehicles - getting the most out of collections

NLC has been awarded some money for the government for electric vehicle charging and asked for it to be put on the Parish Council agenda so that rural areas could benefit from it too.

There is pond project going ahead with North Lincs for new ponds

There will be an Armed Forces day at App Frod in Scunthorpe.

Cllr Waltham also talked about a Collective Switching Service for utilities which has been in place with North Lincs, and he wished to publicise its use in saving parishioners money by finding them the best deals.

The clerk suggested that he be given the power to buy equipment in emergencies to ensure the defibrillator is safe to use when extra supplies are needed. This will go on the next agenda.

A new budget heading will be adopted in October

2306/13 Cadney Gardners Grant

The Clerk explained the advice he had been given from ERNLLCA concerning the Grant Application process and that action could be pursued through the small claims court. However this could be costly and likely to cause distress. The Chair offered to make more enquiries about the situation informally in the hope of finding out what money had been spent, with an eye towards helping fund more projects like this in the future. Cllr Stafford pointed out there There has been activity in the area as far as planting is concerned and Cllr Heath agreed that it would be the right thing if that hasn't been paid for by Cadney Gardeners it is the kind of project they should be funding.
