### **2307/04      To receive Delegate Reports**

Cadney Neighbourhood Watch

Not a lot has happened in the last month, though there was an incident with some youths. And there have been reports of speeding through Cadney.

Neighbourhood Action Team

Fiona - This was with the Brigg NAT, feedback from officers:

Since the previous NAT 8 residential burglaries 13 criminal damage 41 assaults and 8 drug related incidents 18 thefts 5 more vehicles. Neighbourhood priorities: rural crime around hair coursing, antisocial behaviour. Concerning the parish - Horkstow Bridge with youths gathering. If residents are concerned about an issue, they should call 101. The build of reported incidents triggers actions from the police. Nineteen new Speed Cameras have been ordered.

**2307/05 To receive a report from the Ward Councillors**

Cllr Walthm gave the council some new safety signs. Free swimming for children starts on Monday the 24th. There are also reward sessions. New arrangement on compostable waste, meaning more compostable material for North Lincolnshire. Reducing waste that goes into landfill. Waste stream is now 1% unrecyclable. Rural Crime launch has been updated with a new kit which should tackle hare coursing. Library Fines have been cancelled and the amnesty has brought back 500 books.

Pond - The pond is now on the list and if there are not enough new ponds this will be on the first reserve of refurbished ponds.

Fines have been increased on fly tipping going from £400-£1000. There are 70 live enquiries ongoing. £600 Business Tipping, £400 for Street Tipping. Graffiti £500, Littering up to £500.

Cllr James requested information on a mirror at Clayton's Corner junction.

After talking to North Lincs Council, it was reported by the Clerk that generally speaking mirrors can be put on private land but are discouraged for safety and liability concerns. No further action to be taken.

Cllr Leahy reported on Community Speedwatch - meeting with Wayne Goodwin. Three spots where it would be appropriate for the project in Howsham. Down Cadney Road opposite the pumping station, on Main Street outside Number 11 and outside the Old Chapel.

Cadney needs a pavement for the project to viable, and while there are old pavements they need to be reinstated for them to be used. The Clerk will follow this up.
