Neighbourhood Action Team

Cllr Leahy attended the latest meeting was held and the minutes have been circulated the point of main interest being two incidents of hare coursing which have successful investigations.

Brigg will be having a new Sergeant Will Harrison who would like to attend as many Parish meetings as he can. This increases the number of officers for the rural task force which will also be getting to the Fire Service drones.

It was also reported that you can use the Fix My street app to report highways issues.

2506/05 To receive a report from the Ward Councillors

Cllr Sherwood reported that the council has planted 180,000th tree which is well above target for its tree planting projects.

Those who need trees can a contact the council for access and planting

Over 66 can access two months of free off peak access in any North Lincolnshire leisure centre through the Fit for Free scheme. This can be booked with families to help with access.

Slow Cookers will be distributed this year to encourage healthy eating.

2506/06 Questions from Members

There is a dip on Brigg Road that has been sign posted by residents using a cone. This was ran over by a grass cutting crew in June. Councillors asked the Clerk to investigate.

There was a discussion about a dog bin at Cadney Bridge and the council suggested that they would be willing to purchase a bin should it be required the Clerk will get back to the relevant officer.

2506/07 Correspondence

A resident has complained about the length of the grass at the entry to the village from the south. The Clerk talked to the Brigg Clerk and Cllr Sherwood offered to investigate responsibility for the particular piece of land and will report back to the Clerk.

Cllr Leahy raised a concern about the processing of a recent grant. The Clerk paid the grant as he had classified it as a major grant due to its size. Cllr Leahy suggested that there should be a review process before payment such as the sight of receipts.

The Clerk then suggested that there really should be three grant forms. One for Major projects, one for small grants and donations and one for statutory grants such as the Village Hall. The Clerk will draft three new forms for reviews at the next meeting.
