The chair met with representatives from North Lincs Ecology team to discuss the state of the pond. A full report has been received by councillors.

As far as the North Lincs officers were concerned the pond is as healthy as it can be with no water source providing fresh water. This needs to be identified and reestablished if possible. The Chair raised the issues about the Best Kept Village Competition, and how the Parish had been marked down in previous years. The Officers reported that this should not be an issue as the marking is supposed to reflect natural water areas, and they would vouch for the entrants should that happen again.. With that in mind The Chair suggested remarketing it as a wildlife area, which it most certainly is. The Clerk Offered to research notice boards that would reflect the pond's current status and Councillors had an informal discussion about weeding the area.
