Ancholme Catchment Conference
Cllr Tennant reported that:
The Wildlife Trusts are selling Carbon Credits
The majority of flooding is coming from incorrect and out of date infrastructure rather than blocked pipes, ie to small pipes.
Profit margins for Solar Panels being 9% higher than yield compared to 1% on traditional crops which is causing a reassessment in farming long term.
A very interesting meeting.
More Salt Marsh needs to be built to help with long term flooding issues in the area.
