1902/13 PLANNING ISSUES

Manor Farm Static Caravans Update from Planning Enforcement;

Further to our recent email exchange, I visited the above property earlier today and observed the caravans/mobile homes. No one was present on site and a neighbour called when I was leaving who said the owner has been away.

I have checked the planning history for the site and can find no records of approval for the siting of these mobile homes. They appear to be permanent as both had decking etc erected around the structures and have been planted up etc. If they are present on site for the duration of the change of use of the agricultural building (which obtained permission under a prior approval in January 2018) then the mobile homes should be for temporary accommodation only and from what I saw, they are not temporary and will require consent.

I have left my card for the owner to call when she is back from holidays and hope to find out more information from her as to the period they are likely to be on site.
